SURFACE PREPARATION

- 1. Ensure all surfaces are clean, dry and free from oil, dirt and grease.
- 2. Porous surfaces need to be sealed before applying putty. Bostik N49 Primer is recommended to seal concrete.

APPLICATION

Cut off or break off a hand sized portion of putty. Work briefly to soften the putty and apply to substrate. Press firmly into place ensuring a full seal is achieved

LIMITATIONS

- Plumbers Putty Seal should not be used in joints where movement in excess of 5% is expected.
- Plumbers Putty Seal should not be used in exterior situations exposed to strong sunlight. A skin will form and further hardening and cracking may occur with prolonged exposure.

CLEANING

Scrape clean, then use mineral turpentine to remove putty residues. Wash hands using soap and water.

STORAGE AND SHELF LIFE
