Physical Description & Colour: Colourless liquid.

Odour: Citronella/ethanol odour.

Major Health Hazards: Permethrin is harmful to non-harmful via the oral route, with a reported LD_{50} for technical Permethrin in rats of 430 to 4000 mg/kg. Via the dermal route, it is not harmful, with a reported dermal LD_{50} in rats of over 4000 mg/kg, and in rabbits of greater 2000 mg/kg. Possible skin sensitiser. Signs and symptoms associated with mild exposures to organophosphate and carbamate pesticides include: headache, fatigue, dizziness, loss of appetite with nausea, stomach cramps and diarrhoea; blurred vision associated with excessive tearing; contracted pupils of the eye; excessive sweating and salivation; slowed heartbeat, often fewer than 50 per minute; rippling of surface muscles just under the skin.

Section 4 - First Aid Measures

General Information:

You should call The **Poisons Information Centre** if you feel that you may have been poisoned, burned or irritated by this product. The number is **13 11 26 from anywhere in Australia (0800 764 766 in New Zealand)** and is available at all times. Have this SDS with you when you call.

If swallowed, splashed on skin or inhaled, contact a Poisons Information Centre or a doctor at once. Remove any contaminated clothing and wash skin thoroughly. Hospital treatment may be necessary.

Inhalation: First aid is not generally required. If in doubt, contact a Poisons Information Centre or a doctor.

Skin Contact: Irritation is unlikely. However, if irritation does occur, flush with lukewarm, gently flowing water for 5 minutes or until chemical is removed.

Eye Contact: No effects expected. If irritation does occur, flush contaminated eye(s) with lukewarm, gently flowing water for 5 minutes or until the product is removed. Obtain medical advice if irritation becomes painful or lasts more than a few minutes. Take special care if exposed person is wearing contact lenses.

Section 5 - Fire Fighting Measures

Fire and Explosion Hazards: The major hazard in fires is usually inhalation of heated and toxic or oxygen deficient (or both), fire gases. There is a moderate risk of an explosion from this product if commercial quantities are involved in a fire. Firefighters should take care and appropriate precautions. Vapours from this product are heavier than air and may accumulate in sumps, pits and other low-lying spaces, forming potentially explosive mixtures. They may also flash back considerable distances.

Fire decomposition products from this product may be toxic if inhaled. Take appropriate protective measures.

Extinguishing Media: Water fog or fine spray is the preferred medium for large fires. Try to contain spills, minimise spillage entering drains or water courses.

Fire Fighting: If a significant quantity of this product is involved in a fire, call the fire brigade. Accidental release: This product is sold in small packages, and the accidental release from one of these is not usually a cause for concern. Section 10 - Stability and Reactivity

Toxicity: Acute toxicity: Permethrin is harmful to non-harmful via the oral route, with a reported LD₅₀ for technical Permethrin in rats of 430 to 4000 mg/kg. Via the dermal route, it is not harmful, with a reported dermal LD₅₀ in rats of over 4000 mg/kg, and in rabbits of greater 2000 mg/kg. Permethrin caused mild irritation of both the intact and abraded skin of rabbits. It also caused conjunctivitis when it was applied to the eyes. The 4-hour inhalation LC₅₀ for

rats was greater than 23.5 mg/L, indicating practically no inhalation toxicity. The toxicity of Permethrin is dependent on the ratio of the isomers present; the cis-isomer being more toxic.

There is no data to hand indicating any particular target organs.

Permethrin is Classed by SWA as a potential sensitiser by skin contact.
