BLACK LIGHT UV LAMP

To ensure maximum output in the Black Ultraviolet frequency range, the lamp should be replaced annually.

ROUTINE MAINTENANCE:

- Ensure the Bug Zapper is disconnected from its power source before performing any maintenance.
- The clog free vertical grid is self-cleaning, however in areas of heavy infestations of mosquitos and other flying insects, cleaning the grid may be necessary. Use an air blower or brush to dislodge insects. DO NOT remove the cage of the zapper to clean it.
- 3. Globes are to be replaced from the base of the Bug Zapper. **DO NOT** remove the cage of the zapper to replace the globe
- 4. Globes can be purchased on line at www.bugzapperlamps.com.au
- 5. Mozzie Attract Octenol lure is a 30 day slow release lure. When expired, dispose of lure by wrapping in paper, placing in a plastic bag and putting it in the garbage.
- 6. Mozzie Attract Octenol lures can be purchased at Bunnings in the Electronic Insect Control Department or online www.bugzapperlamps.com.au

WARNING: all servicing/ maintenance of this product must be carried out by a qualified electrician or returned to the service department of The Kelly Company Pty Ltd at the address shown on the front of this manual.

STORAGE:

Mozzie Attack Plus: Store in a cool dry place when not in use. Clean vertical hanging grid (as directed above) if required.

Octenol Lure (Mozzie Attract): Store in closed original package in a cool well ventilated area.

DISPOSAL

Mozzie Attack Plus: Dispose of expired Black Light UV globe in with general waste, they are non-recyclable.

Octenol Lure: Dispose of used lure and holder by wrapping in paper, placing in a plastic bag and putting in the garbage.

This manual will provide you with directions for the safe and efficient operation of your Mozzie Attack Plus Bug Zapper. Failure to operate in accordance with the instructions in this manual may cause damage to the unit.

- ✓ The outer protective screen (cage) has been designed to prevent fingers or foreign objects from contacting the charged killing grid.

POSITIONING THE BUG ZAPPER

To achieve maximum performance from the Mozzie Attack Plus Bug Zapper, please review and observe the following recommendations.

- 1) Flying insects are attracted to the black light UV lamp, when they come into contact with the electrically charged grid surrounding the lamp they are killed.
- 2) Locate the Bug Zapper as far away from outdoor dining/entertaining areas as possible.
- 3) The Bug Zapper is weatherproof so it can be hung outside, ensure the plug is covered. In extreme weather conditions, turn the Zapper off and/or remove from hanging position.
- 4) The replaceable octenol lure is not waterproof, if using the lure, keep it under cover.
- 5) Do not position the Bug Zapper over dining tables, chairs or next to doors.
- 6) Make sure the hanging ring is securely attached to the item to which it will hang from.
- 7) The Bug Zapper will be more effective if hung so all four sides are accessible to insects.
- 8) If a power extension lead is used, it must be suitable for outdoor use. Keep the extension lead dry and off the ground; avoid heat and sharp edges and keep the plug covered in used in an outdoor power socket.

CORRECT OPERATION OF THE BUG ZAPPER

- 1) This Bug Zapper is designed to attract and kill mosquitos and other light sensitive insects.
- 2) During the mozzie season from spring to autumn your Bug Zapper should operate from dusk to dawn. Replace the Octenol lure every 30 days for optimum performance.
- 3) When correctly installed, your Bug Zapper will interrupt the 10-14 day breeding cycle of mozzies and other flying insects and under normal conditions will noticeably decrease the insect infestation level.
- 4) This Bug Zapper is IPX4 waterproof rated and rain or moisture will not affect its operation, however the octenol lure is not, and the lure is most effective when used under cover.
- 5) More than one unit may be required depending on the size of the insect breeding area.

STINGER MOZZIE ATTACK PLUS BUG ZAPPER

REPLACEMENT PARTS 10W UV Black Lamp

The UV black light lamp is long wave and safe to use. The black UV light attracts mozzies and other flying insects more than white UV light. For maximum attraction of flying insects, replace the lamp after 12 months.

Octenol Lure (Mozzie Attract)

The octenol lure has been scientifically proven to attract mosquitos. It is slow release and will remain effective for 30 days once removed from its plastic pouch.

Once inside the holder, it should be attached to the outer cage of the Mozzie Attack Plus. **Replacement lures:** Available from Bunnings in the Insect control/ Zapper section
